Rules

Objective: This school/camp will provide a safe, caring, clean, wholesome and fun environment for both students and staff at all times.

Therefore, **there is “zero” tolerance** for the following:

1. Illicit drugs of any form used on or near the premises by anyone at any time.
2. Obscenities and profanities, expressed in any form, will not be tolerated by anyone at any time. Consequence is suspension or expulsion.
3. Anyone bringing weapons or other dangerous items to school/camp will suffer severe legal consequences.
4. Fighting by anyone or lack of respect for teachers/counselors will not be tolerated. Consequence is suspension or expulsion.

Please Note:

This school/camp promotes Christian standards and requires all participants of the school/camp to follow its code of conduct, dress code and routines at all times. Daily worship/praise service is an integral part of our summer school /day camp program.

Immediate compliance with summer school/ day camp rules is expected of each student. Insubordination results in suspension/expulsion.

Mutual respect is expected of students, staff, visitors, and parents during all interactions at this center.

Parents will be responsible for the cost of repairs to any property damaged by their child. In addition, the child could be expelled.

Students and staff must dress and behave discreetly:

Skirts and shorts are to be no more than 2ö above the knee. They must not be tight fitting. Blouses must properly conceal chest area and the whole torso. Pants must be worn with belts at the waist. Girls are permitted to wear earrings which should be no more that (1) inch in length or width. Boys are not permitted to wear earrings and headbands on the premises. Consequences include suspension. **If a student wears a top that is too tight, the student will be required to purchase an orange t-shirt that will be worn in class that day. If they refuse, they will not be allowed to continue in the program.**

NO: Wearing of headphones, playing radios, hats worn backwards, gum chewing, name calling, teasing, cheating, lying and stealing. **Also, no electronic games including but not limited to I-pods, mp3 players, video games, and cell phones are not allowed in the classroom and activity areas.** Consequences may include confiscation of prohibited material, suspension and expulsion.

Students may not leave the site before the dayø program is completed or the director has received written permission from parents. Visiting by studentsøfriends is not permitted.
